



#### **AGREEMENT**

#### ON ACADEMIC EXCHANGE AND COOPERATION BETWEEN

# Denau Institute of Entrepreneurship and Pedagogy (REPUBLIC OF UZBEKISTAN)

AND

## Hacettepe University

## (REPUBLIC OF TURKEY)

The Denau Institute of Entrepreneurship and Pedagogy from Uzbekistan, represented by Rector Prof. Oybek Ruziyev, on the one part, and Hacettepe University from Turkey, represented by Rector Prof. Cahit Güran, on the other part (both hereinafter referred to as the "Parties" collectively, or "Party" individually), taking into consideration the strong international relations between Denau Institute of Entrepreneurship and Pedagogy and Hacettepe University, and recognizing the necessity and potential for developing further bilateral relations between the two countries in educational and scientific fields of cooperation, wishing to contribute to the development of cooperation between their educational institutions in the aforementioned fields, hereby conclude this Agreement on academic exchange and cooperation with the following provisions:

## **ARTICLE 1**

Based on the principle of mutual benefit and respect for each other's independence, the Parties will foster:

- a) Faculty and administrative staff exchange;
- b) Student exchange at graduate and undergraduate levels;
- c) Development and realization of joint educational programs, including programs with double-diploma awarding, whereby graduate students who successfully complete an Associate's Degree may register for a Bachelor's Degree at the other university;
- d) Joint research activities;
- e) Organization of academic meetings and symposiums;

- f) Publication of articles, reports, and other scientific materials by university faculty members, staff, and students in the periodical publications of the partner university;
- g) Exchange of academic information, publications, materials, and knowledge;
- h) Other forms of educational and scientific activities as may be mutually agreed by the two Parties.

In order to give effect to these forms of cooperation, representatives of individual faculties and institutes within the two Parties will be encouraged to consult each other regarding specific plans for collaboration in any or all of the aforementioned areas.

## **ARTICLE 2**

The implementation of each program based on this Agreement shall be negotiated and agreed upon by the Parties under a separate agreement prior to the initiation of the particular program. This separate agreement will clearly describe the functions and activities to be developed, work schedules, personnel profiles, financing, rights and obligations of each Party, as well as the necessary documents required to determine the goals and scope of each program.

## **ARTICLE 3**

It is implicit that every activity undertaken under this Agreement is approved by the appropriate officials at each institution and complies with each institution's academic and fiscal constraints. The results of cooperative research, including but not limited to any newly produced intellectual property, shall be managed earnestly and fairly through consultation between the Parties.

## **ARTICLE 4**

In the implementation of this Agreement's provisions, the two universities shall act in accordance with the legislation of their home countries and intergovernmental agreements on cooperation in the field of education. All cooperative activities mentioned in Article 1 shall comply with all applicable laws, regulations, and guidelines of the country and university in which the activity is conducted.

#### **ARTICLE 5**

This Agreement shall come into effect upon the signature of this document by authorized representatives of both universities and shall remain in force until terminated by either university by notification. Notification of termination must be made at least six months prior to the termination date. Regardless of termination, the

Parties shall continue to fulfill their obligations until all participants who have commenced a program have completed the term in session at the time of termination. This Agreement may be modified at any time following due consultation between the Parties.

## **ARTICLE 6**

This Agreement is made in English. Two copies of this Agreement shall be made, with one copy held by each university, and both copies shall serve as originals.
