

**CO-OPERATION AGREEMENT**  
**between**  
**IVANE JAVAKHISHVILI TBILISI STATE UNIVERSITY**  
**and**  
**HACETTEPE UNIVERSITY**

**I. GENERAL PROVISIONS**

1. Ivane Javakhishvili Tbilisi State University (Tbilisi, Georgia), represented by Rector Alexander Kvitashvili, and Hacettepe University (Ankara, Turkey), represented by Rector Prof. Dr. A. Murat Tuncer, hereby agree to establish the following cooperation agreement for the purpose of promoting and expanding international development, understanding and friendship by stimulating and supporting educational, scientific, Professional and intercultural activities.

**II. OBLIGATIONS OF THE PARTIES**

2. Universities agree to carry out, cooperatively, the following activities:
  - 2.1. Joint and collaborative research
  - 2.2. Organization of joint conferences, seminars, courses for qualification, summer schools, cognitive excursions and practical work by providing access to the information facilities of both parties;
  - 2.3. Exchange of academic and administrative staff members, graduate and undergraduate students;
  - 2.4. Cooperation in the further qualifications of universities lecturers;
  - 2.5. Exchange of information, materials and research publications in those fields which are of interest to both universities;
  - 2.6. Participation in the European Union New Neighborhood programmes and other international projects.
  - 2.7. Sharing of experiences in administrative reforms and implementation of the Bologna Process Guidelines.
  - 2.8. Sharing best practices of library management
  - 2.9. Cooperation in sport and cultural activities

**III. CONDITIONS OF THE AGREEMENT**

1. The cooperation between parties shall be implemented on the principle of parity.
2. The coordinator of each party will elaborate annual working programs.
3. The hosting university shall cover the expenses of teaching and administrative staff, student accommodation, as well as meal within the constraints of their existing financial resources (up to ten persons during year from each party).
4. The sending university covers the travel costs.

**IV. VALIDITY AND TERMINATION OF THE AGREEMENT**

7. The agreement shall enforce on day of its signing for a period of 5 years.
8. The parties have right to terminate the Agreement within a written notice to the other university period of three month upon.
9. The agreement is drawn in two originals in English language. Both originals are identical to each other and have equal legal power.

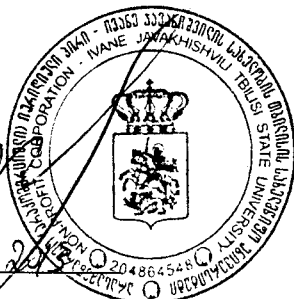
